ACC will continue to operate on a standalone basis but within the same group as Actrol Parts (a leading national refrigeration and air conditioning wholesaler and distributer with turnover in excess of \$110 million) which was acquired by funds advised by Catalyst in May 2010.

ACC's current General Manager, Tim O'Leary will lead the business. Commenting on the sale Tim said, "Russell Amiguet has developed ACC into one of the strongest businesses of its type in the country. The team is keen to build on this base and further expand the capabilities and reach of the business to deliver the market leading air conditioning solution for customers. The ACC team are looking forward to working with Actrol Parts and Catalyst as our new partners".

Catalyst Investment Director, Nick Speer, said "ACC is a high quality business that has generated impressive growth. Catalyst is keen to support the team in further expanding the business both locally and interstate and leveraging the combined strengths of the Actrol Parts/ACC group."

Funding for the transaction was sourced from equity funds advised by Catalyst and debt provided by Commonwealth Bank and Westpac. The equity investment was made by Catalyst Buyout Fund 2, a A\$438m fund raised in 2008.
